LAST WILL AND TESTAMENT

I, PATRICIA BAZELL-TAYLOR of P.O. Box 2859, 105 Marbel Drive, off West Bay Road, Grand Cayman KY1-1112, Cayman Islands, hereby revoke all former Wills and testamentary dispositions made by me and I declare this to be my Last Will and Testament.

1. I hereby appoint and nominate my friend NOEL THOMAS REILLY of Laguna del Mar, 441 West Bay Road, Grand Cayman, Cayman Islands, my daughter JAN STEWART RIDING of Mandeville Cottage, 43 Bishop Crescent, Shepton Mallet, Somerset BA4 5XX, United Kingdom and my granddaughter, POPPY BAZELL of P.O. Box 2859, 105 Marbel Drive, off West Bay Road, Grand Cayman KY1-1112, Cayman Islands to be the Executors and Trustees of this my Will, (hereinafter referred to as "my Trustees").

2. I DECLARE that the expression "my Trustees" herein contained shall include the Trustee or Trustees hereof whether original additional or substituted AND THAT my Trustees shall be Trustees for the purposes of the Settled Land Law and the Trusts Law and all settlements and trusts deemed to arise thereunder.
3. I FURTHER DECLARE that if at any time there shall be a sole Trustee of this my Will, whether originally appointed or not, that Trustee shall have all the powers of two Trustees for the purposes of the Settled Land Law and the Trusts Law including the power to receive capital trust moneys when acting alone.
4. I DIRECT that as soon as possible after my decease my Trustees shall pay all my just debts, funeral, tombing and testamentary expenses on the express understanding that all such payments are recoverable from my estate.
5. I AUTHORISE my Trustees to employ if required, professional persons to assist in the executorship and trusteeship at such remuneration (to be paid out of my Estate) and on such other terms as shall be agreed.

6. I GIVE DEVISE AND BEQUEATH all of my estate both real and personal of whatsoever kind and wheresoever situate to my Trustees UPON TRUST to sell and convert into money with power to postpone such sale, conversion and getting in for such period as my Trustees shall judge expedient AND as to the moneys to arise from such sale, conversion or getting in I DIRECT my Trustees to divide the same into the parts and to the persons specified hereunder:

- a) CI\$200,000 to my son ROBERT BAZELL;
- b) CI\$10,000 to IRVINE LONG;
- c) CI\$10,000 to the person appointed by my Trustees in their absolute and unfettered discretion to care for my dog Goosie and in this respect I give my Trustees full power to (i) determine the person best suited to caring for my said dog and (ii) pay this sum to them without being liable to see to the applications thereof, and receipt of any such person shall be a full and sufficient discharge for such payment or payments;

d) As to the balance remaining after the above bequests:

(i) 1/3 share to my daughter JAN STEWART RIDING;

(ii) 1/3 share to my brother MICHAEL GREEN

(iii) 1/3 share to be divided equally amongst the following grandchildren: CHARLIE BAZELL, FREDDIE BAZELL POPPY BAZELL, EMILY BAZELL BARNABY BAZELL and EMILY HLADKYJ.

7. I DECLARE that during the minority of any beneficiary who shall be entitled to any interest vested or contingent hereunder my Trustees may apply the whole or any part of the income or capital of such interest for or towards his or her maintenance education advancement or benefit with full power to pay the same to the parent or guardian or the adult person in charge of any such beneficiary and without being liable to see to the applications thereof, and receipt of any such person shall be a full and sufficient discharge for such payment or payments. For the purposes of this clause 7 the term "minority" shall be deemed to be a reference to

the period during which a beneficiary is under the age of eighteen years.



MY TRUSTEES may take and act upon the opinion of any Attorney-at-Law whether in relation to the interpretation of this my Will or any other document or statute or as to the administration of the trusts hereof without being liable to any of the persons beneficially interested in respect of any act of omission done or made in accordance with such opinion but nothing in this clause contained shall prohibit my Trustees from applying to the Court if


they shall think fit or shall prohibit any of the beneficiaries from so doing.




