TO WHOM IT MAY CONCERN

- 1) I, MARTINA MORALES PAVON, a Honduran citizen, of legal age, hereby declare under oath that I know Ms MARCELA POWELL UNRUCH, a Honduran citizen, currently domiciled at 19 Midnight Road, Savannah, with contact number (345) 922-8058.
- 2) That the said Ms Unruch came to see me at my workplace and told me that she had a good business, which consisted in my giving her CI\$800.00 (eight hundred), and she would return a profit of CI\$5,000.00 (five thousand) per month during three months.
- 3) My employer was present and I trusted Ms Marcela Ulruch, so I gave her the said amount of CI\$800.00. That happened on September 25, 2020. The date she mentioned to give me the promised monies (CI\$5,000.00 for the first month) was October 21, 2020.
- 4) That day, October 21,2020, one week after the date for payment, Ms Marcela asked me to give her two more weeks to collect the money. After some time I called her again, and she said that she had given the money to another person who was in charge, and said that the business was no longer active, and promised to pay me back my invested money that I gave her in the term of two weeks.
- 5) After some more weeks elapsed, I contacted her to claim my money, and she said that she didn't have anything to give me, and that it was up to me if I wanted to go to the Police or to Court, anyway she wouldn't give me my money back, even less the supposed profits.
