UPON the application by the Plaintiffs by their Ex Parte Summons dated 29 January 2021 (the "**Confidentiality Summons**")

AND UPON reading the Plaintiffs' Application for Leave to Apply for Judicial Review dated 12 February 2021 (the "**Leave Application**")

AND UPON reading the affidavit and exhibits set out in Schedule 1 to this Order (Confidential) and the letter from Maples and Calder to the Court dated 23 March 2021

AND UPON the Court being satisfied that the Confidentiality Summons be dealt with administratively without the need for an oral hearing

AND UPON the Court being satisfied that this application be determined in private

ANY PERSON WHO KNOWS OF THIS ORDER AND DISOBEYS THIS ORDER OR DOES ANYTHING WHICH HELPS OF PERMITS ANY PERSON TO WHOM THIS ORDER APPLIES TO BREACH THE TERMS OF THIS ORDER MAY BE HELD TO BE IN CONTEMPT OF COURT AND MAY BE IMPRISONED, FINED OR HAVE THEIR ASSETS SEIZED.

IT IS HEREBY ORDERED until further order of the Court as follows:

- 1 The Clerk of the Court not place a copy of the Leave Application on the Register of Writs and Other Originating Processes.
- 2 The Court being satisfied that it be strictly necessary, all documents filed, or to be filed, in relation to the Confidentiality Application and Leave Application be placed in

envelopes and thereafter sealed prior to being placed on the Court file, and such sealed envelopes not be open to inspection by any person other than the parties to this proceeding and their attorneys, except with the prior leave of the Court, such application to be made on at least 14 days' written notice to the parties hereto. The Clerk of the Court do place copies of the following documents on the Court file without being first placed in sealed envelopes:

2.1 The Confidentiality Summons; and

2.2 This Order, but not including Schedule 1 (Confidential).

3 The Clerk of the Court do place a copy of this Order, but not including Schedule 1 (Confidential), on the Register of Judgments and Orders.

4 Nothing in this Order shall prevent the publication of this Order (but not including Schedule 1 (Confidential)) or the reporting of any written reasons delivered in this proceeding, save that the parties be at liberty to apply for any orders in respect of any written reasons pursuant to Practice Direction No. 3 of 1997 as they may be advised.

5 For the avoidance of doubt, nothing in this Order shall prevent the parties or any other person from publishing, communicating or disclosing any information as was already in, or thereafter comes into, the public domain in the Cayman Islands (other than as a result of a breach of this Order).

6 The Leave Application be adjourned until further Order of the Court with general liberty to apply.

7 The costs of and occasioned by this application be costs in the cause.
