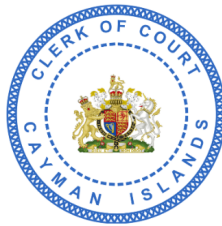

PARTICULARS OF CLAIM

The Defendant entered into an agreement with the Plaintiff to rent an apartment at the location of 427A Will T Drive, Lower Valley, Bodden Town, Grand Cayman.

The Defendant moved into the apartment on 27th September 2020 and paid the rent however no security deposit was paid.

The Defendant moved out of the apartment on 20st February 2021. She failed to pay the following for utilities:

Electricity - \$69.10
Water - \$30.00
Total: \$99.10

The Plaintiff spoke to the Defendant on a number of occasions requesting that she pay the utilities. The Defendant has failed to make any other payments towards the outstanding utility bills.

In addition the Defendant cut out the bathroom pipes and caused \$300.00 in damages to the bathroom.

The defendant now owes the following sums:

- Damages - \$300
- Utility- \$99.10
- **Total: \$399.10**

AND the Plaintiff claims:

1. The sum of CI\$399.10
2. Fixed costs of \$150.00, plus filing fees of \$25.00 and Bailiff 's service fees.
