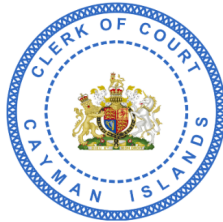

PARTICULARS OF CLAIM

The Defendants entered into an agreement with the Plaintiff to rent an apartment at the location of 427A Will T Drive, Lower Valley, Bodden Town, Grand Cayman.

The Defendants moved out of the apartment in February 2021 and owe the following for utilities for the months of January and February 2021

Electricity - \$181.60 (\$101.60 - January & \$80.00 - February)

Water - \$141.42 (\$79.00 - January & \$62.42 - February)

Total: \$323.02

The Plaintiff spoke to the Defendant on a number of occasions requesting that they pay the outstanding utilities however they have failed to do so. In addition a hose was turned on in the house which flooded the room and damaged a room door which had to be replaced. The defendants now owes the following sums:

- New Door - \$175.00
- Utility \$323.02
- **Total: \$498.02**

AND the Plaintiff claims:

1. The sum of CI\$498.02
2. Fixed costs of \$150.00, plus filing fees of \$25.00 and Bailiff's service fees.
