**ORDER**

---

**UPON** reading the letter from Counsel for the Joint Official Liquidators (**JOLs**) of Opus Trinity SPC (the **Company**) dated 29 March 2021

**AND UPON** reading the Summons issued by the JOLs dated 29 March 2021 (**Summons**)

**AND UPON** reading the Seventh Affidavit of Kris Beighton dated 26 March 2021 (**Seventh Affidavit**)

**AND UPON** issuing the minute of order dated 8 April 2021

**IT IS ORDERED** that:

1. The JOLs' remuneration for the period 1 June 2016 to 31 May 2020 in relation to the Private Equity Gulf III Segregated Portfolio (**PEG III**) is fixed and approved in the sum of USD 95,839;
2. That the Company be dissolved in accordance with Order 22 of the Companies Winding Up Rules (2018 revision) (**CWR**), and the JOLs be released from any further duties in relation to the Company, subject to paragraph 3 below;
3. Notwithstanding that the JOLs are discharged from office, the JOLs are authorised to make payment of the remuneration, fees, expenses and disbursements in respect of the official liquidation of the Company from the remaining bank account held by PEG III at Butterfield Bank in the Cayman Islands referred to at paragraph 27 in the seventh affidavit of Kris Beighton dated 26 March 2021, and once the payments are made, request closure of the bank account; and

4. That the Company's books and records be preserved and stored together in electronic format for not less than seven years from the date of the dissolution of the Company and may accordingly be destroyed on or after 31 March 2028, pursuant to Order 22, rule 2 (4(a) and (b)) of the CWR.
