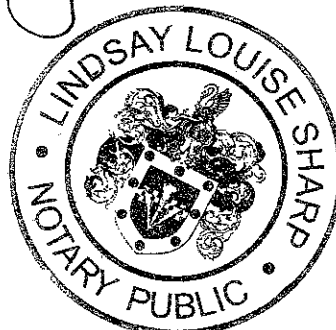

The Last Will and Testament of Andrew Michael Leigh Barcroft

1. Revocation

I ANDREW MICHAEL LEIGH BARCROFT [date of birth 15th day of October 1949] of "Pelham Place" 67 Brunswick Street Maidstone Kent ME15 6NP REVOKE all former wills and testamentary dispositions and DECLARE this to be my last will ('my Will')

2. Funeral wishes

- (a) I HAVE no specific instruction and give my Executors discretion on the disposal of my body as they shall see fit
- (b) I AUTHORISE my Executors to incur such expense in implementing these provisions as they SHALL in their absolute discretion think fit

3. Appointment of executor

- (a) I APPOINT my former wife PAULINE ANGELA BARCROFT of "Pelham Place" 67 Brunswick St Maidstone Kent ME15 6NP and my son LEIGH ASHBY BARCROFT of 18 Whitchurch Close Maidstone Kent ME16 8UR to be the executors of my Will
- (b) 'my Executors' shall mean the persons appointed by sub-clause 3.(a) above or any other person who acts as my personal representative


4. Interpretation

I DECLARE that where the context so admits the definitions and declarations contained in clause 9 SHALL apply to my Will

5. Devise of real property – absolute

- (a) I GIVE free of inheritance tax all my share and interest (if not previously sold) in Cayman Brac East Block No. 107A Parcels 98 And 99 458 Southside East Cayman Brac KY2-2101 Cayman Islands or any other such property I may own (or hold under lease) as my principal residence at my death ('the property') together with any other assets still located in the Cayman Islands to my former wife PAULINE ANGELA BARCROFT and my son LEIGH ASHBY BARCROFT in equal shares absolutely and SUBJECT TO the provision in clause 8(b)
- (b) I DECLARE that if at the date of my death my share and interest in the property SHALL BE subject to a binding but uncompleted contract for sale this gift shall take effect as a gift of my share of the net proceeds of sale of the property

6. Administration of my estate

MY Executors SHALL HOLD my Estate UPON TRUST to PAY and discharge ALL my debts funeral testamentary and administration expenses and GIVE effect to ALL legacies

7. Transfer to trustees

SUBJECT to the trusts DECLARED above my Executors SHALL transfer to or otherwise place under the control of the Trustees the Trust Fund to be HELD UPON with and SUBJECT to the following trusts powers and provisions of my Will

8. Residuary gift

(a) SUBJECT as above the Trustees SHALL HOLD the capital and income of the Trust Fund for the following beneficiaries as shall survive me in equal shares:

(i) my former wife PAULINE ANGELA BARCROFT absolutely

(ii) my son LEIGH ASHBY BARCROFT absolutely

(b) PROVIDED that if any beneficiary in clause 8.(a) above shall fail to obtain a vested interest leaving issue who survive me then such issue shall take by substitution and if there shall be more than one of such issue they shall take in equal shares per stirpes but so that no issue shall take whose parent is alive and so capable of taking

9. Definitions and interpretation

IN my Will where the context so admits:

(a) 'my Estate' shall mean ALL my real and personal property of every kind wherever situate including ALL property of every kind wherever situate over which I have a general power of appointment and the money investments and property from time to time representing all such property

(b) I DECLARE that:

(i) CLAUSE headings are included for reference purposes only and do not affect the interpretation of my Will

(ii) WORDS denoting the singular shall include the plural and vice versa and the masculine includes the feminine and vice versa

(iii) PERSON shall include a body of persons either corporate or incorporate

(iv) REFERENCES to any statutory provision shall include any statutory modification or re-enactment of such provisions

- (d) 'the Trust Period' shall mean the period ending on the earlier of:
 - (i) THE last day of the period of 125 years from the date of my death which period (and no other) shall be the applicable perpetuity period or
 - (ii) SUCH date as the Trustees shall by deed at any time or times specify (not being a date earlier than the date of execution of any such deed or later than a date previously specified)


10. The schedule of administrative powers

IN my Will where the context so admits any reference to the Schedule of Administrative Powers shall mean the standard provisions of the **Society of Trust and Estate Practitioners** (2nd Edition) shall apply *including* the Special Provisions

11. For the avoidance of doubt

- (a) I DECLARE that the name and gender of any person named in my Will and my relationship to such person shall mean such name, person and relationship as is applicable at the date of execution of my Will which shall be read as if the Gender Recognition Act (2004) had not been passed into law
- (b) THE reverse side of every page of my Will is intentionally left blank with The Testimonium and Attestation following this clause on the next page
