**UPON** reading the Summons dated 29 March 2021

**AND UPON** reading the Fifth Affidavit of Jess Shakespeare sworn 29 March 2021

**AND UPON** reading the Joint Official Liquidator's (the "**JOLs**") final report and accounts dated 9 March 2021

**AND UPON** the Court considering the further correspondence from the JOL's attorneys, Bedell Cristin

**AND UPON** the Court being satisfied that the application was suitable to be dealt with on the papers without a hearing

**IT IS HEREBY ORDERED** that:-

**APPROVAL OF THE OFFICIAL LIQUIDATOR'S REMUNERATION**

1. That the final fees and expenses of the JOLs and their professional advisors in the amount of US\$49,034, for work undertaken by them in relation to the liquidation of the Woodbridge Fund (In official liquidation) (the "**Company**") for the period commencing 3 June 2020 to 28 February 2021 are approved for payment out of the assets of the Company;
2. That the requirement contained in CWR O. 22, r. 1 (3) to publish a notice of the JOLs' application for an order that the Company be dissolved be dispensed with;

## **DISSOLUTION**

3. That the Company be dissolved with such dissolution to take effect on 28 June 2021 (the **Dissolution Date**);
4. That Jess Shakespeare and Simon Conway be discharged as JOLs upon the dissolution of the Company; and
5. That the liquidation files of the JOLs and the Company's books and records be retained by the JOLs for a period of no less than 3 years from the Dissolution Date and thereafter may be destroyed.
