**AND UPON** reading the Third Affidavit of Graham Robinson, sworn 27 April 2021 (**Robinson 2**) and Exhibit GR-2 to Robinson 2

**AND UPON** hearing counsel for the OL

**IT IS HEREBY ORDERED THAT:**

1. The fees of the OL:
  - a. for the period from 14 May 2020 up to and including 28 February 2021 in the amount of KYD\$67,871.40; and

b. from 1 March 2021 to the date of the dissolution of the Company in the sum of KYD\$2,000, (amounting in aggregate to KYD\$69,871.40)

be approved and paid from the liquidation estate;

2. The Company be dissolved on the date 14 days after the date of this order;
3. The OL's liquidation files containing preferential creditor bank details be destroyed upon dissolution;
4. The remaining OL's liquidation files be preserved for at least three years after the dissolution of the Company;
5. The Company's books and records recovered by the OL be preserved for at least three months after dissolution of the Company and shall then be destroyed; and
6. The OL's costs of the Application shall be paid out of the assets of the Company as expenses of the liquidation.
