AND UPON the Court being satisfied that the Application is suitable to be disposed of administratively "on the papers", without the need for an oral hearing, in accordance with Section B1.1 of the Financial Services Division Guide, Second Edition

IT IS HEREBY ORDERED THAT:

1. Claire Loebell of R&H Restructuring (Cayman) Ltd., Windward 1, Regatta Office Park, PO Box 897, Grand Cayman, KY1-1103, Cayman Islands, be immediately released from the performance of any further duties as a JOL pursuant to Order 5, rule 4(1)(c) of the Companies Winding Up Rules, 2018 (the "**CWR**") and not be required to prepare a report or accounts in accordance with Order 5, rule 4(6) of the CWR; and

2. the costs of and incidental to this Application be paid out of the assets of the Company as an expense of the official liquidation.
