THIS PLAINT has been issued against you by the above-named Plaintiff in respect of the claim set out on the next page.

Within 14 days after service of this Plaintiff on you, counting the day of service, you must either satisfy the claim or return to the Court Office, P.O. Box 495, George Town, Grand Cayman KY1-1106, the accompanying Acknowledgment of Service form stating therein whether you intend to contest this action. If you intend to defend the action, in whole or part, you must set out **full particulars of your Defence** in the space provided in the Acknowledgment of Service form.

If you fail to satisfy the claim or fail to return the Acknowledgment of Service form containing the full particulars of your Defence, the Plaintiff may apply for a **default judgment** without any further notice to you.

PARTICULARS OF CLAIM

1. On 5 December 2016 the Defendant entered into an agreement with the Plaintiff to borrow CI\$1400 to which the Plaintiff lent the Defendant.
2. The Defendant received the funds with the understanding that the amount borrowed would be repaid within 6 months making the date for repayment 5 June 2017.
3. The Plaintiff has not received any money from the Defendant to date. The Defendant has been promising to repay the funds but has not done so. The Plaintiff has contacted the Defendant on numerous occasions over the years to recover these funds.
4. The Plaintiff wrote to the Defendant demanding the payment of the outstanding amount owing to the Plaintiff via whatsapp.

THE PLAINTIFF is therefore entitled to and claims:

- 1 The sum of CI\$1,400 being the outstanding borrowed amount;
- 2 Interest in the sum of CI\$170.22 calculated at the prescribed rate pursuant to s.34 Judicature Law (2007 Revision) from 5 June 2017 to 13 July 2021 and CI\$0.09 per day until the matter is determined;
- 3 Fixed costs in the amount of CI\$150, alternatively, costs to be assessed.

If within the time for returning the Acknowledgment of Service the Defendant pays the total amount claimed of CI\$1,720.22 further proceedings will be stayed. The money must be paid to the Plaintiff and/or his Attorneys-at-Law.
