## PARTICULARS OF CLAIM

1. 6th March 2020, Martyn Bould, Chairman of Bould Consulting Limited secured rental accommodation for a new staff member Brady Harrison, Work Permit to be processed with Bould Consulting Limited paying the deposit for the accommodation.
2. 9th March 2020 Bould Consulting Limited paid the rental deposit of CI\$ 1,250.00 via online transfer from their Butterfield account to Nelina McLaughlin's Butterfield account and a receipt was provided to confirm receipt of funds.
3. 19th March 2020 Ms McLaughlin was advised by email that in view of the current COVID 19 pandemic, the closure of the Owen Roberts International Airport, various international travel restrictions/self isolation plus issues obtaining the WP, Brady's assignment had been deferred and the deposit to be refunded. Ms McLaughlin advised that payment would be made in April 2020.
4. Throughout the course of April 2020 and September 2021 various payment promises have not materialized.
