
PARTICULARS OF CLAIM

- 1 On 23rd July 2021 MS Sharis Ford, contacted Mrs. Joyce Ann Green from Tedrick Green T/A Gotcha till Pay Day loans requesting a loan for CI\$840.00. Ms. Ford had had received a small loan a few months prior, so Mrs. Joyce Ann advised Ms., Ford to go to the office located, at 80 North Church Street. Shop # 04. George Town, to see employee, Mr. Albert Francisco, and completed the loan contract, which the defendant did. Once the application was completed Ms. Sharis, received the cash, proceed of the loan, with the understanding that the loan was to be paid back in full on 23 August 2021
- 2 When the loan became due Mrs. Joyce Ann contacted Ms. Sharis, for the repayment, at which time the Ms. Sharis became combative and disrespectful, stating that she did not have the money to pay back and that Mrs. Green should not have given her the loan if she was going to wait until she can pay it back. Mrs. Green advise her that she would be sending the matter to a collection agency, at that point Ms. Sharis, told Mrs. Green if she cannot wait, to go ahead and sent it to collection agency or take her to court, and then hanged up. Mrs. Joyce Ann G tried to call Ms. Sharis, right back a few times, but could not reach her; it appeared that Ms. Sharis, had block Mrs. Green's calls and blocked her on WhatsApp.
- 3 On September 10, 2021 Mr. Tedrick Green T/A Gotcha till Pay Day Loans, forwarded. Ms. Shari's, file to UE Debt Collection Agency. On September 10th 2021 UE Debt Collection Agency tried several times to connect with Ms. Sharis Ford, but was not successful. After five days of calling Ms. Sharis personal number with no success UE Agency called Ms. Ford called her place of employment; Jacques Scott Wines & Sprits. UE informed Ms..Sharis that we were hired by Tedrick Green T/a Gotcha till Pay Day loans, to recover the monies she had borrowed on 23rd of July 2021. Ms. Sharis, did not say much she, we advised her that we had been trying to reach her for about six days but did not received a reply to any of our voice messages, and we would be sending her our collection letter via email. Ms. Sharis, then demanded to know what email address we had for her. UE Collection Agency sent the first collection letter to Ms. Sharis, on September 16 2021, via email. After seven days and no reply we tried to contact Ms. Sharis on her cell phone at which time it appeared she had block UE Agency number, we then sent our final demand letter was sent on 23rd September 2021. Ms. Sharis, only reply to UE Collection Agency, on 24th September 2021. stating she was not able to pay

AND the Plaintiff claims:

- (1) **The sum of CI\$1,749.40 (CI\$1274.40 loan repayment, Collector fees CI\$475.00)**
- (2) Interest in the sum of \$ calculated at the prescribed rate from of 2021 to date.
- (3) Interest to continue until this matter is settled 1% per day
- (4) Fixed costs of \$ alternatively costs to be assessed.
