If you intend to defend the action, in whole or in part, you must set out **full particulars of your defence** in the space provided in the Acknowledgment of Service form.

If you fail to satisfy the claim or fail to return the Acknowledgment of Service form containing full particulars of your defence, the Plaintiff may apply for a **default judgment** without any further notice to you.


PARTICULARS OF CLAIM

1. On the 24th June 2021 the Defendant herein were engaged by the Plaintiff for the purposes of drafting architectural and structural plans in respect to renovations of a property ("the Agreement").
2. Arising from the said Agreement the Defendant herein raised an invoice in the sum of CI\$15,498 and requested payment of the sum of CI\$5,166 in advance ("the Advanced Sum").
3. In compliance with the Agreement the Plaintiff paid the Advanced Sum.
4. Despite multiple requests, in breach of the Agreement the Defendant herein failed, refused and neglected to supply the architectural and structural plans.
5. On or about the 6th October 2021 the Plaintiff terminated the Agreement and demanded return of the Advanced Sum.
6. The Defendant has failed, refused or neglected to return the Advanced Sum.

AND the Plaintiff therefore claims:

- a) Judgment in the sum of CI\$5,166.00;
- b) Pre- and post-judgment interest pursuant to section 34 of the Judicature Act (2021 Revision) and the Judgment Debts (Rates of Interest) Rules (2021 Revision) at the rate of 2.375% per annum from the date of issue of this Plaint accruing at the rate of CI\$0.33 per diem until paid in full;
- c) Fixed costs of \$250.00 or alternatively costs to be assessed;
- d) Court costs of \$25; and
- e) Such further and other relief as to this Honourable Court may seem just.
