If you fail to satisfy the claim or to return the Acknowledgment within the time stated, or if you return the Acknowledgment without stating therein an intention to contest the proceedings, the Plaintiffs may proceed with the action and judgment may be entered against you forthwith without further notice.

GENERAL INDORSEMENT

The Plaintiffs claim:

Against the First Defendant:

1. A declaration that the First Defendant holds 32,165 shares in the Second Defendant (the “Shares”) on trust for the First Plaintiff;
2. An order that the Shares stand charged with the First Plaintiff’s beneficial interest;
3. An order prohibiting the First Defendant from disposing or dealing with the Shares, otherwise than in accordance with paragraph 5 below;
4. A declaration that the First Defendant has been unjustly enriched at the expense of the First Plaintiff;
5. Orders that the First Defendant do account for the Shares (including any rights or benefits which the First Defendant has received as a result of holding the Shares) and do make restitution of the Shares to the First Plaintiff; and
6. Damages for loss arising from breach of contract by the First Defendant for failing to issue shares in the First Defendant to the First Plaintiff.

Against all Defendants, and each of them:

7. Damages for deceit and/or conspiracy;
8. Damages and/or equitable compensation for loss arising from misrepresentation and/or breach of contract;
9. All necessary accounts and inquiries;

10. Interest pursuant to section 34 of the Judicature Act (2021 Revision) and/or alternatively pursuant to the equitable jurisdiction of the Court;
11. Costs; and
12. Further and other relief.

DIRECTIONS FOR ACKNOWLEDGMENT OF SERVICE**OF WRIT OF SUMMONS**

1. The accompanying form of Acknowledgment of Service should be completed by an Attorney acting on behalf of the Defendant or by the Defendant if acting in person.

After completion it must be delivered or sent by post to the Law Courts, P.O. Box 495G, George Town, Grand Cayman.

2. A Defendant who states in his Acknowledgment of Service that he intends to contest the proceedings must also serve a defence on the Attorney for the Plaintiffs (or on the Plaintiffs if acting in person).

If a Statement of Claim is indorsed on the Writ (i.e. the words "Statement of Claim" appear on the top of page 2), the Defence must be served within 14 days after the time for acknowledging service of the Writ, unless in the meantime a summons for judgment is served on the Defendant.

If the Statement of Claim is not indorsed on the Writ, the Defence need not be served until 14 days after a Statement of Claim has been served on the Defendant.

If the Defendant fails to serve his defence within the appropriate time, the Plaintiffs may enter judgment against him without further notice.

3. A Stay of Execution against the Defendant's goods may be applied for where the Defendant is unable to pay the money for which any judgment is entered. If a Defendant to an action for a debt or liquidated demand (i.e. a fixed sum) who does not intend to contest the proceedings states, in answer to Question 3 in the Acknowledgment of Service, that he intends to apply for a stay, execution will be stayed for 14 days after his Acknowledgment, but he must, within that time, issue a Summons for a stay of execution, supported by an affidavit of his means. The affidavit should state any offer which the Defendant desires to make for payment of the money by instalments or otherwise.

Notes for Guidance

1. Each Defendant (if there are more than one) is required to complete an Acknowledgment of Service and return it to the Courts Office.
2. For the purpose of calculating the period of 14 days for acknowledging service, a writ served on the Defendant personally is treated as having been served on the day it was delivered to him.
3. Where the Defendant is sued in a name different from his own, the form must be completed by him with the addition in paragraph 1 of the words "sued as (the name stated on the Writ of Summons)".
4. Where the Defendant is a FIRM and an attorney is not instructed, the form must be completed by a PARTNER by name, with the addition in paragraph 1 of the description "Partner in the firm of (.....)" after his name.
5. Where the Defendant is sued as an individual TRADING IN A NAME OTHER THAN HIS OWN, the form must be completed by him with the addition in paragraph 1 of the description "trading as (.....)" after his name.
6. Where the Defendant is a LIMITED COMPANY the form must be completed by an Attorney or by someone authorised to act on behalf of the Company, but the Company can take no further step in the proceedings without an Attorney acting on its behalf.
7. Where the Defendant is a MINOR or a MENTAL PATIENT, the form must be completed by an Attorney acting for a guardian ad litem.
8. A Defendant acting in person may obtain help in completing the form at the Courts Office.
