PARTICULARS OF CLAIM

(Here set out in numbered paragraphs the grounds upon which the Plaintiff claims that the Defendant is indebted to him or is liable to pay damages to him)

1. On October 29, 2021, the Defendant borrowed \$1,689.00 from the Plaintiff (Procollect Intl) and agreed to pay back the full amount plus 20% of the amount borrowed by November 22, 2021, of a total of \$2,027.00
2. A contract was signed between the Plaintiff and the defendant fully explaining the terms and conditions including the late fees and legal action. to which the defendant stated that he fully understood (exhibit 1)
3. On November 22, 2021, the plaintiff called the defendant concerning the payment and the defendant stated that he was very busy and would pay it the next day
4. On Wednesday December 1, 2021, the plaintiff called the defendant informing him that if payment was not made, we would have to seek legal action. The Plaintiff stated that he did not want to go to court and asked if he could make a payment on Friday 3 December 2021. The plaintiff informed the defendant that the minimum payment would have to be \$275.00, the defendant replied and stated by 12 noon on Friday 3 December 2021 payment would be made.
5. On Friday 3 December 2021 at 6:33 the plaintiff whatsapp the defendant about the payment. At 7:25 the defendant replied by sending a picture saying he just finish, and he was busy.
6. As of November 23, 2021, late fees of \$50.00 was added to the balance \$2,077.00
7. As of Monday December 6, 2021, 20% was added to the balance as per contract total balance \$2,492.00
8. Interest at \$0.17 per day

AND the Plaintiff claims:

1. The sum of \$2,492.00
2. Fixed costs of \$175.00, \$25.00 filing fee and process server fee \$125.00 alternatively costs to be assessed.
3. Total cost \$2,817.00
