**AFFIDAVIT OF ADMINISTRATOR**

I, **ZHU YAN** of Room 2601, Building 15, #6 Chao Wai Avenue, Chao Yang District, Beijing, the People's Republic of China (the "PRC"), being the applicant for a grant of letters of administration in the estate of the late **ZUO HUI**, deceased (the "Deceased") **MAKE OATH AND SAY** as follows:

I believe that:

1. There was no land vested in the said Deceased which was settled previously to his death and which remained settled notwithstanding his death.
2. The said Deceased was domiciled in the PRC at the time of his death.
3. Other than his true name, the said Deceased was not known by any other name in connection with the ownership of assets in the Cayman Islands.
4. The net value of the said Deceased's Cayman Islands estate is approximately USD3,650,484.
5. I declare that I am the widow of the Deceased.
6. There is now produced and shown to me a copy of an affidavit of law from attorney-at-law WU Hao and marked as Exhibit "ZY-1" confirming that I am a person beneficially entitled to the estate of the Deceased by the law of the place where the Deceased died domiciled.
7. Therefore, in accordance with Rule 37(1)(b) of the Probate and Administration Rules (2008 Revision) of the Cayman Islands, I am a person entitled to apply for a grant of letters of administration in the Deceased's estate.

- 8. ZUO Wenzhi, the Deceased's father, is also entitled to apply for a grant of letters of administration in the Deceased's estate. Wenzhi is aware of this application for a grant of administration in the Deceased's estate and has renounced his right to apply and confirmed his consent to my application for such grant of administration. A copy of Wenzhi's letter of renunciation and consent dated this 25<sup>th</sup> day of October, 2021 is hereby exhibited to this Affidavit as "ZY-2".
- 9. ZUO Xiaoxi and Alex ZUO, the Deceased's children, hold minority interests in the estate of the Deceased.
- 10. The other persons known to me as having an immediate or contingent interest in the said estate is ZUO Wenzhi, the Deceased's father.

I make this affidavit in support of my application in the premises and confirm that the above facts are true to the best of my knowledge and belief.

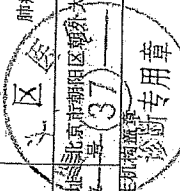
