

1. Recovering payment for work performed during period; September 2019 to March 2021
2. Outstanding balance in respect of collections per employment contract dated April 2019
3. As of 31st March 2021 the outstanding collections were KYD\$9,640.35
4. Payments were received between 30th April 2021 & 1st October 2021 of KYD\$6,268.90, leaving a remaining balance due to myself of KYD\$3,371.45
5. The defendant should also pay interest at the prescribed rate on the balance owed as of the date of this Plaint at the per diem rate per day of KYD\$0.23 until the balance has been repaid as well as the fixed costs.

AND the Plaintiff claims:

- 1 The sum of KYD\$3,371.45 .
- 2 Interest in the sum of \$ 60.05 calculated at the prescribed rate from to date.
- 3 Fixed costs of \$ 300.00 , alternatively costs to be assessed.
