ORDER AND RELIEF CLAIMED

The Applicant seeks payment of a debt owed to him for the purchase of his car along with stock rims and tyres by the Respondent. The Applicant seeks the \$4500KYD remaining on the total payment of \$10,000.

AND The Applicant also seeks interest on the outstanding debt

AND the Applicant seeks his legal costs incurred in attempting to recover this debt.

FURTHER AND In the Alternative The Applicant seeks the return of the car in good condition forthwith along with the stock rims and tyres that were provided at the time of sale.

APPLICANT'S GROUNDS

1. On 11th March 2021 the Applicant sold a Nissan Skyline Vin number #CPV35-601718 to the Respondent for the sum total of \$10,000.KYD. The Defendant agreed to pay the applicant in instalments. The Respondent paid the first instalment of \$5000 via money transfer at the Butterfield bank. The Respondent then owed the Applicant a further \$5000. A copy of the sales agreement is attached hereto and marked *Exhibit 1*.
2. A further \$500 was paid by the Respondent on 30th April 2021. A copy of the bank confirmation of the transaction is attached hereto and marked *Exhibit 2*.
3. Thereafter no further payments were forthcoming. The Applicant has attempted on several occasions to contact the Respondent, the Respondent initially promised to make good on the payments. Thereafter when the Applicant contacted the Respondent, the Respondent either refused to take his call and tried to avoid him or was hostile and would tell the Applicant that he would have to take him to court to get the rest of his money.

4. The Respondent owes the Applicant the money or should return the car with stock rims and tyres to the Applicant forthwith. As the vehicle has not been paid for in full by the Respondent yet the Respondent has been the said vehicle it in the interim period.

5. In the interim period The Applicant asks the court for an order preventing the Respondent from driving the vehicle or in anyway altering the vehicle or disposing of the vehicle until this matter is resolved. Such an order is required as should the car need to be returned the Applicant believes the Respondent will do what he can to ensure the car is devalued or strip the car of items in it for individual sale. Further the Applicant seek an expedited hearing so that this matter can be resolved.

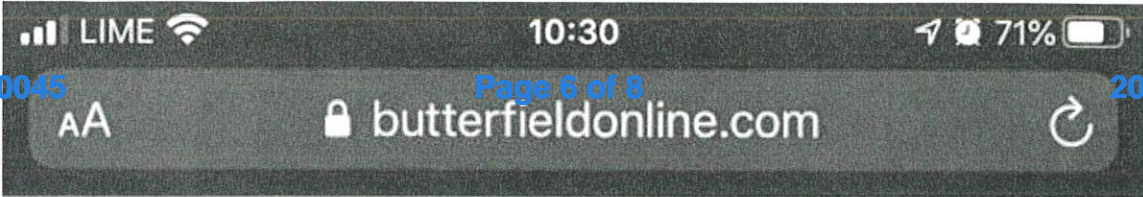
