
**PARTICULARS OF CLAIM**

(Here set out in numbered paragraphs the grounds upon which the Plaintiff claims that the Defendant is indebted to him or is liable to pay damages to him)

1. On 5<sup>th</sup> December 2021 the defendant requested that I construct a stone wall 50 feet long by 31” high at one (1) of his construction sites located in rum point, north side. It was agreed that \$4,500.00 would be paid to complete the wall. This amount included labor and materials. A down payment of \$3,500.00 was made on 7<sup>th</sup> December 2022. On start of the wall it became apparent that the wall height would not be 31” but would range from 36” up to 49” with an average height of 42” and an actual length of 59 feet long. I communicated this finding to the defendant and told him an additional amount of \$1,600.00 would be due. The wall was completed on 24 December 2021.
2. The amount owed is 3 months and 18 days overdue.
3. The balance owing is \$2,600.00

AND the Plaintiff claims:

1. The sum of \$2,600.00
2. Interest in the sum of \$21.00 calculated at the prescribed rate of 4% from 24 December 2021 to 11 April, 2022.
3. Fixed costs of \$ 125.00
