PARTICULARS OF CLAIM

1. Pursuant to an Agreement the Plaintiff agreed to provide the Defendant with accounting and administrative services on a consultancy basis ("the Agreement
2. The Plaintiff and the Defendant agreed that the Defendant would pay to the Plaintiff the sum of CI\$300.00 per month for such services.
3. From February 2021 to September 2021 the Defendant failed to make the monthly payments as set out in the Agreement.
4. By letter dated 9 September 2021 from the Plaintiff's attorneys, the Plaintiff made demand of sums due by the Defendant to the Plaintiff in the amount of CI\$2,400.00. Notice of Termination was also provided in that letter advising the termination date of 8 November 2021, being 60 days from service of the notice.
5. By letter dated 10 November 2021 from the Plaintiff's attorneys, the Plaintiff made demand of final sums due being CI\$2,778.88 as at 8 November 2021, as set out below:

1. The sum of CI\$2,778.88
2. Interest in the sum of \$34.34 calculated at the prescribed rate from 9 November 2021 to 18 May 2022
3. Fixed costs of CI\$350.00, alternatively costs to be assessed.
