

I, Cliff Eddingston Ebanks of **West Bay, Grand Cayman** is the son of the late **Earl Clifton Ebanks** named on the Death Certificate provided with this application), being the same, respectively, as Cliff Eddingston Ebanks the Executor named in the last Will and Testament of the late **Earl Clifton Ebanks** formerly of **50A Duxies Lane, West Bay, Grand Cayman, Cayman Islands**, surviving the deceased, being over the age of 18 years and not having renounced probate AND which said Will was made in Grand Cayman on 18 May 2021 and which said Will at the time of death of the deceased having been found with Cliff Eddingston Ebanks, son of the said deceased AND which the said Will, together with the Certificate of Death is annexed hereto, HEREBY apply for a Grant of Probate of the said Will enclosed herewith our joint Affidavit in that behalf and we undertake that in the event of such Grant being made to us, we will:-

- (a) within six months of the Grant of Probate of the said Will to us, prepare a true inventory of the said Estate and exhibit and file the same in the Probate Registry; and
- (b) within one year of such Grant to us, we will administer the said Estate according to the tenor of the Will and the directions, if any, of the Court and file in the Probate Registry a general accounting for the whole of the assets of the said Estate.

THIS IS THE LAST WILL of me, **EARL CLIFTON EBANKS**, of 50A Duxie's Lane, West Bay, Grand Cayman, Cayman Islands.

REVOCAION OF ALL FORMER WILLS AND TESTAMENTARY DISPOSITIONS

1. I HEREBY REVOKE all former Wills and testamentary dispositions made by me.

STATEMENT OF DOMICILE

2. I HEREBY DECLARE myself to be resident and domiciled in the Cayman Islands.

APPOINTMENT OF EXECUTOR

3. I APPOINT my son **Cliff Eddingston Ebanks** of West Bay, Grand Cayman, Cayman Islands to be Executor ("my Executor") of this, my Will.

APPOINTMENT OF LEGAL SERVICES PROVIDER

- 4.1 I declare that I wish to appoint H. Phillip Ebanks, Attorney at Law, of 19 Walkers Road, George Town, PO Box 10104 Grand Cayman, KY1-1002, to act in all aspects of probate and to advise and counsel my Executor.
- 4.2 Legal service expenses incurred shall be deducted from my Estate prior to gift, devise and bequest in paragraph 5 below.

ESTATE

- 5.1 My Estate includes (a) my home and property at Registration Section West Bay North West, Block 1C, Parcel 24 ("my Home") and all other real estate held by

me at the time of my death or in which I hold any interest, (b) any bank account or accounts held in my name in any bank or financial institution or credit union (“my Bank Accounts”) and any accounts in which I hold an interest, and (c) benefit received or to be received from my personal injury claim which is being pursued in the USA and in which I am represented by Weitz and Luxenberg PC, in New York, USA (“my Personal injury claim”) and (d) all chattels in my possession or in which I have an interest at the time of death.

- 5.2 I GIVE, DEVISE AND BEQUEATH the legal and beneficial interest in my Home in equal shares to my son Cliff Eddingston Ebanks (“my Son”), my granddaughter, Britney Kay Quiz (“my Granddaughter”), my wife Sofia Tiempo Ebanks (“my Wife”) and my stepdaughter, Elizabeth Tiempo Tutor (“my Step-daughter”).
- 5.3 I GIVE, DEVISE AND BEQUEATH all sums in my Bank Accounts and in any account in which I hold an interest to my Son, my Granddaughter, my Wife and my Stepdaughter in equal shares.
- 5.4 I GIVE, DEVISE AND BEQUEATH the benefit of sums received or to be received in due course from my Personal Injury Claim as follows:
- (a) In the event my Son or my Granddaughter shall for any reason whatsoever not each receive benefit of 25% share in my Home, then from sums received from my Personal Injury and before any other disbursement to any other beneficiary from such receipts, my Son and my Granddaughter each shall receive a sum equal to 120% of the sum they would have received had they benefited from receiving 25% share in my Home.
- (b) Subject to satisfaction of paragraph 5.4 (a), the balance of benefit if any received from my Personal Injury Claim shall be distributed in the following

shares:

- (i) 60% of the benefit to my Son and my Granddaughter in equal shares.
- (ii) 40% of the benefit to my Wife and my Stepdaughter in equal shares.

5.5 In the event my wife shall predecease me or die without receiving benefit due to her under this my Will, then her share shall be divided equally between my Son, my Granddaughter and my Stepdaughter.

5.6 In the event my Stepdaughter shall predecease me or die without receiving benefit due to her under this my Will, then her share shall be divided equally between my Son, my Granddaughter, and my Wife.

5.7 In the event my Son shall predecease me or die without receiving his benefit under this my Will, then his share shall go to my Granddaughter.

5.8 In the event my Granddaughter shall predecease me or die without receiving benefit due to her under this my Will, then her share shall go to my Son.

INTERPRETATION PROVISIONS

6.1 The clause headings are included for reference only and do not affect the interpretation of this my Will.

6.2 The singular shall include the plural and the masculine gender shall include the feminine and neuter genders and vice versa.

6.3 Words importing persons shall include firms, corporations and charities.

6.4 References to any statutory provision shall include any statutory modification or

re-enactment thereof.

APPLICABLE LAW

7. This Will and any codicil to it shall be governed by and construed in accordance with the laws of the Cayman Islands.

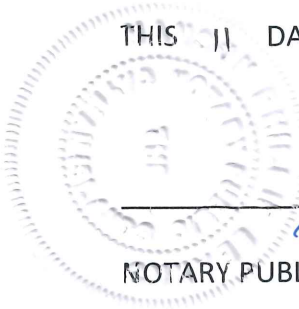
