I, JEWEL NINA ETHELYN WALKER, of #10 Market Street 374, Camana Bay, KY1-9006, Cayman Islands, British West Indies, being the Personal Representative named in the last Will and Testament of the late, Ronald James Walker aka Ronald Walker, late of House #82, Glidden Lane, West Bay, Grand Cayman, Cayman Islands, British West Indies, and surviving the deceased, being over the age of eighteen (18) years, and not having renounced probate, which said Will was made at West Bay, Grand Cayman, Cayman Islands, and the said Will, at the time of the death of the deceased, having been held in safe custody by his Personal Representative which said Will, together with the Certificate of Death, are annexed hereto, hereby apply for a grant of Probate of the said Will to me. I enclose herewith my affidavit in that behalf and undertake that, in the event of such grant being made to me, I shall: -

- (a) Within six (6) months of the grant to me of probate of the said Will prepare a true inventory of the said estate and exhibit and file the same in the Probate Registry; and
- (b) Within one year of such grant to me, I shall administer the said estate according to the tenor of the Will and the directions, if any, of the Court and file in the Probate Registry a general account accounting for the whole of the assets of the said estate.

3. That Ronald James Walker aka Ronald Walker, formerly of House #82, Glidden Lane, West Bay, Grand Cayman, Cayman Islands, British West Indies, died on or about the 14<sup>th</sup> day of June, 2020, at the Cayman Islands Government Hospital, George Town, Grand Cayman, Cayman Islands, British West Indies, domiciled in the Cayman Islands, at the age of 73 years, 8 months and 18 days.
4. I believe the paper writing now produced to me and marked by my signature to contain the true and original Last Will and Testament of the deceased.
5. To the best of my knowledge, information and belief, there was no land vested in the deceased which was settled prior to his death, and not by his Will, and which remained settled land, notwithstanding his death.
6. That the deceased was not known by any name other than that his true, full and complete name of Ronald James Walker in connection with the ownership of any property which he may have owned in the Cayman Islands prior to, or at the time of his death.
7. The deceased was domiciled in the Cayman Islands at the time of his death.
8. That Ronald James Walker aka Ronald Walker is one and the same person.
9. That the net value of the deceased's estate is approximately US\$9,826.88, consisting of 646 ordinary shares in Caribbean Utilities Company, Ltd.



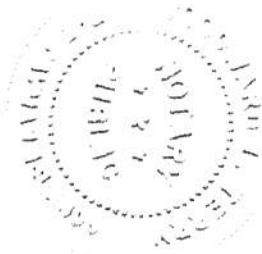
