



- (b) Within one year of such grant to us, we shall administer the said estate according to the tenor of the Will and the directions, if any, of the Court and file in the

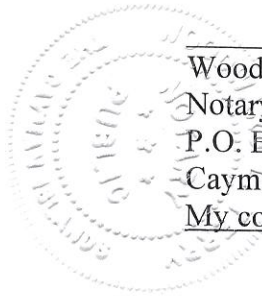
