PARTICULARS OF CLAIM

- 1 On January,2022 the Defendant borrowed \$1500.00 from the Plaintiff and agreed to pay back the full amount plus 20% of the amount borrowed by February 2022 of a total of \$1800.00
- 2 A contract was signed between the Plaintiff and the defendant fully explaining the terms and conditions including the late fees and legal action. to which the defendant stated that she fully understood
- 3 In February 2022 the defendant called and stated that she could not make any payments as her father died, She was informed of the late fee and interest. The Plaintiff agreed to the new balance and signed said contract for the balance to be paid in March 2022 \$2,220.00.
- 4 Since February the plaintiff has called the defendant every month begging for payment, however the defendant continue to give excuses such as her father died, or her mother died, or the government did not pay her. The defendant has stated that she has thoughts of suicide which caused the Plaintiff to inform her that this is not good as she is teaching our young children and having thoughts of suicide.
- 5 The defendant was informed that if payment was not made, we would pursue legal action.
- 6 As of Tuesday July 26, the Defendant has an outstanding balance of \$1,763.00 and as per contract 50% to be added to the balance total \$2,644.00 and simple interest at 2.75% \$0.20 per day

AND the Plaintiff claims:

- (1) The sum of \$2,644.00
- (2) Fixed costs of \$175.00, \$25.00 filing fee and process server fee \$125.00 alternatively costs to be assessed.
- (3) Interest at \$0.20 per day
- (4) Total sum \$2,969.00


