I, WILLIAM HENRY McTAGGART SR., of P.O. Box 902, George Town, Grand Cayman, Cayman Islands HEREBY REVOKE all former testamentary dispositions made by me and declare this to be my Last Will and Testament.

1. I appoint my beloved wife, DEBBIE MARIE McTAGGART, of P.O. Box 902, George Town, Grand Cayman, Cayman Islands and my beloved son, WILLIAM H. McTAGGART JR., of P.O. Box 1957, George Town, Grand Cayman, Cayman Islands to be the Executors and Trustees of this my Will.
2. I direct payment of all my just debts, funeral and testamentary expenses.
3. It is my desire that I be given a Christian burial at sea.
4. I give to my beloved wife, DEBBIE MARIE McTAGGART, forty-seven percent (47%) of my shareholdings in the business known and trading as "UNCLE BILL'S" and/or "W.H. McTAGGART AND SON" absolutely.
5. I give to my beloved son, WILLIAM HENRY McTAGGART JR., eighteen percent (18%) of my shareholdings in the business known and trading as "UNCLE BILL'S" and/or "W.H. McTAGGART AND SON" absolutely.

6. I give to my beloved wife, DEBBIE MARIE McTAGGART, fifty percent (50%) of my shareholdings in the company W.H. McTaggart Co. Ltd. (including the land and building situate thereon described at the Land Registry as Registration Section, GEORGE TOWN CENTRAL, BLOCK 13EH, PARCELS 146 and 147) absolutely.
7. I give to my beloved son, WILLIAM HENRY McTAGGART JR., fifty percent (50%) of my shareholdings in the company W.H. McTaggart Co. Ltd. (including the land and building situate thereon described at the Land Registry as Registration Section, GEORGE TOWN CENTRAL, BLOCK 13EH, PARCELS 146 and 147) absolutely.
8. I hereby give my old family home and the property upon which it is situate at Fort Street described on the Land Register as Registration Section, GEORGE TOWN COMMERCIAL, BLOCK OPY, PARCEL 21 to my Trustees upon trust to sell the same with power in their absolute discretion to postpone such sale for so long as they shall think fit without being liable for loss and I direct that the proceeds of sale be distributed in the following manner:-
  - (a) A sum not exceeding CI \$10,000.00 to be given to each of my lawful brothers and sisters living at the time of my death, for the avoidance of doubt, I hereby declare that the payment of such sum is to be made in such manner and in such amount as shall be determined by my Trustees in their absolute discretion.
  - (b) That the balance of the proceeds of sale shall be divided equally between my six lawful children, WILLIAM HENRY McTAGGART JR.,

9. If any of my children shall die in my life time or after my death but before attaining a vested interest leaving issue who have attained the age of eighteen years or marry under that age, such issue shall take by substitution and if more than one, in equal shares per stirpes that share of my estate which such deceased child of mine would have taken if he or she had survived me and attained a vested interest but that so no issue shall take whose parent is alive and capable of taking.
10. If any of my children or grandchildren shall die in my life time or after my death but before attaining a vested interest leaving no issue who shall survive and attain a vested interest in my residuary estate under the foregoing trusts then the share of such deceased child or grandchild of mine including any share or shares which may accrue thereto by virtue of this present provision shall accrue in equal shares if more than one to the share or shares of the other children or grandchildren of mine the trust whereof shall not have failed at the date of such accrual.
11. My Trustees shall have the following additional powers:-
  - (a) My Trustees may at any time or times raise any part or parts not exceeding altogether one-half out of the share in my estate to which any child or grandchild of mine is absolutely, presumptively or contingently entitled and may pay or apply the same as my Trustee

shall think fit for their advancement, benefit or maintenance of such child or grandchild.

12. My Trustees may take and act upon the opinion of any Counsel or Attorney-at-Law practising in the Cayman Islands, whether in relation to the interpretation of this my Will or any other document or statute or as to the administration of the trusts hereof without being liable to any of the persons beneficially interested in respect of any act or omission done or made in accordance with such opinion but, nothing in this Clause contained shall prohibit my Trustees from applying to the Court if they shall think fit or shall prohibit any of the beneficiaries from so doing.
13. Monies comprised in my residuary estate may be invested or applied in the purchase of or at interest upon the security of such stocks, funds, shares, securities or other investments of property of whatsoever nature and wheresoever situate and whether producing income or not including the purchase or improvement of landed property anywhere in the world for use as a residence and whether involving liability or not upon such personal credit, with or without security as my Trustees may in their absolute discretion think fit to the intent that my Trustees shall have the same full and unrestricted powers of investing and varying investments in all respects as if they were absolutely and beneficially entitled thereto.
14. My Trustees shall not be personally liable for any breach of trust whether by way of commission or omission done or suffered unless it shall be proved that at the time of his or her doing or suffering such breach or his or her concurrence therein or he or she was guilty of dishonesty and/or fraud and that such act or default was done or suffered by him

part

or her in bad faith and in particular but without prejudice to the generality of the foregoing provision he or she shall not be bound to take any proceedings against a Co-Trustee or past Trustee or his Personal Representatives for any breach or alleged breach of trust committed or suffered by such Trustee. My Trustees shall be answerable and accountable only for their own acts, receipts, neglects or defaults and not for those of any other Trustee nor of any Banker, Broker or other person with whom any trust money or securities may be deposited and shall not be responsible for the insufficiency or deficiency of any securities nor for any other loss unless the same happens through his or her own wilful default, neglect or dishonesty.

15. I devise and give all my real and personal property of whatsoever kind and wheresoever situate over which I have the power of testamentary disposition and not otherwise disposed of by this my Will or any Codicil hereto to my beloved wife, DEBBIE MARIE McTAGGART absolutely.
16. If my beloved wife shall predecease me or shall not survive me for thirty days then I hereby devise and give any and all my real property of whatsoever kind and wheresoever situate and over which I have the power of testamentary disposition not otherwise disposed by this my Will or any Codicil hereto to my Trustees to hold the same upon trust for my two beloved daughters, PATRICIA SUSAN McTAGGART and LISA MARIE McTAGGART in equal share per stirpes.
17. It is my desire that the dwelling house situate at Crewe Road and the property upon which it is situate being Registration Section, GEORGE TOWN EAST, BLOCK 20E, PARCEL 166, together with the dwelling house

situate at North Side, being Registration Section, RUM POINT, BLOCK 33B, PARCEL 126 be retained by my Trustees as residences for the benefit of my two youngest children, PATRICIA SUSAN McTAGGART and LISA MARIE McTAGGART, until they shall attain a vested interest.

18. If my beloved wife, DEBBIE MARIE McTAGGART, shall predecease me or shall not survive me for a period one month then I appoint my trusted sister-in-law, JENNIFER YOLANDA MOORE, of George Town, Grand Cayman to be the Guardian of my beloved daughters, PATRICIA SUSAN McTAGGART and LISA MARIE McTAGGART.

19. This Will is to be construed and interpreted according to the Laws of the Cayman Islands.





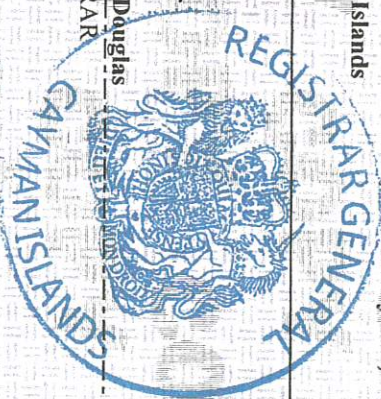
