And we annex hereto our Affidavit in support of my application and the Certificate of Death of the late Kenneth Earl Yates, deceased.

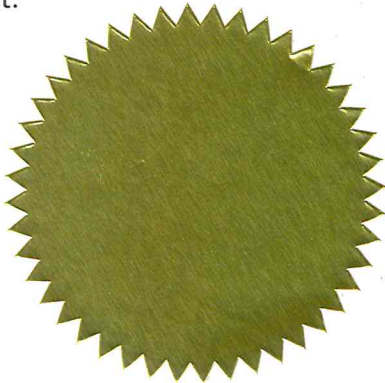
**BOND**

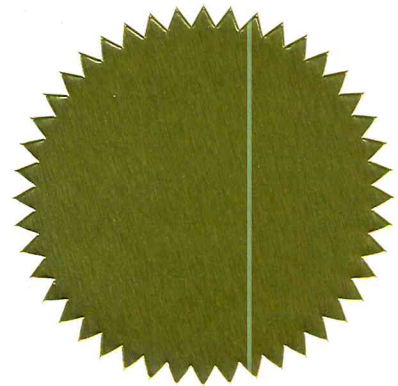

**BOND OF SURETY**

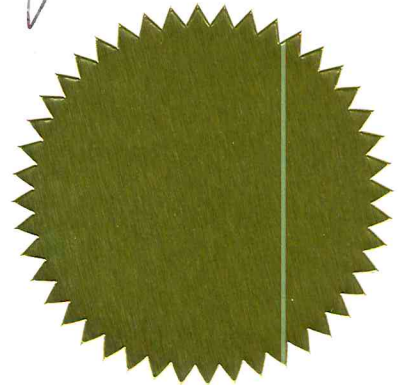
