SECTION 23 (1)**



**ANN SEON** of Point Drive, L'anse aux Epines, Saint George, Grenada, and **HOPKIN** of Gully High, 9 Turtle Back Ridge, St. James, Barbados, being the Executors (together the "**Executors**") named in the Will of **ROYSTON HOPKIN** deceased (the Grant of Probate of which was granted to us out of the Supreme Court of Grenada and the United States of America and the United States of America (the "**Court**") on 16<sup>th</sup> December 2020 (being the equivalent of a grant of probate under the laws of the Cayman Islands and hereinafter referred to as the "**Grant of Probate**"), being over the age of eighteen years and not having renounced Probate, and the Grant of Probate, together with an order of the Court dated 15<sup>th</sup> February 2021 whereby the Court ordered that copies of the Will shall not be made available to the public without further order of the Court; an order of the Court dated 28<sup>th</sup> May 2022 whereby the Court ordered that certified redacted copies of the Will be issued to us for the purpose of resealing the Grant of Probate in the Cayman Islands; the redacted Will and the certificate of death, is annexed hereto, HEREBY APPLY for resealing of the Grant of Probate of the estate of the said Deceased and enclose our Affidavit in that behalf and undertake that in the event of a resealed grant being made to us, we will:

1. within six months of the resealed Grant of Probate, prepare a true inventory of the said estate in the Cayman Islands and exhibit and file the same in the Probate Registry; and
2. within one year of such resealed Grant of Probate, arrange to have the assets comprising the said estate in the Cayman Islands administered according to the directions, if any, of the Court and arrange for the Executors to file in the Probate Registry a general accounting for the whole of the assets of the said Cayman Islands estate.
