
PARTICULARS OF CLAIM

1. The Plaintiff is a Bank carrying on business at its branch at 200 Elgin Avenue, PO Box 1097, George Town, Grand Cayman KY1-1102 and elsewhere, and the Defendant is and at all material times, has been a customer of the Plaintiff at the said branch.
2. As at 24 October 2022 Defendant was indebted to the Plaintiff in respect of a MasterCard Standard #5425-6871-6720-0005 in the principal sum of US\$2,065.64, plus contractual interest which will continue to accrue at a rate of US\$1.15 per diem.
3. The Plaintiff has made written demand for repayment by letter from its attorneys but the Defendant has failed to repay the said sum.

AND THE PLAINTIFF CLAIMS AGAINST THE DEFENDANT:

1. Payment of the said sum of US\$2,065.64;
2. Contractual interest on the above principal sum at the rate of US\$1.15 per diem, and continuing until payment at the same rate pursuant to the Plaintiff's standard banking terms and conditions.
