2. As at 24 October 2022 Defendant was indebted to the Plaintiff in respect of a Visa Infinite Card Account #4466-9200-0514-0015 in the principal sum of US\$ 7,712.86, plus contractual interest which will continue to accrue at a rate of US\$ 3.86 per diem.
3. The Plaintiff has made written demand for repayment by letter from its attorneys but the Defendant has failed to repay the said sum.

AND THE PLAINTIFF CLAIMS AGAINST THE DEFENDANT:

1. Payment of the said sum of US\$ 7,712.86;
2. Contractual interest on the above principal sum at the rate of US\$ 3.86 per diem, and continuing until payment at the same rate pursuant to the Plaintiff's standard banking terms and conditions.
