
PARTICULARS OF CLAIM

2. As at 24 October 2022 Defendants are indebted to the Plaintiff in respect of a Loan Account #***-14083 in the principal sum of CI\$5,627.72, together with arrears plus interest which will continue to accrue at a rate of CI\$2.38 per diem.
3. The Plaintiff has made written demand for repayment by letter from its attorneys but the Defendant has failed to repay the said sum.
