**PARTICULARS OF CLAIM**

1. The Defendant is and was at all material times a Cayman Islands registered company carrying on business pursuant to the laws of the Cayman Islands. The Defendant's registered office is 90 Godfrey Nixon Way, PO Box 11861, Grand Cayman KY1-1010, Cayman Islands.
2. Between July and November 2021, the Defendant issued 10 cheques to the Cayman Islands Government for the payment of services, all of which were dishonoured by the bank and returned to the Government due to insufficient funds. The dishonoured cheques are:

3. The total sum owed to the Cayman Islands Government is CI\$13,507.50, inclusive of bank administration fees.
4. Notwithstanding the demands for payment being made on the Defendant, she has failed to satisfy this debt.
5. The Defendant having acknowledged the debt as a valid debt entered into a Promissory Note on 2 November 2021, promising to repay the then outstanding amount of \$14,417.00.
6. To date the Defendant has failed or neglected to make full payment on this amount to the Plaintiff despite repeated demands for payment.
7. As a result of the above, the Plaintiff is entitled to the relief claimed in this proceeding.

**AND THE PLAINTIFF** claims:

- a. CI\$13,507.50 being the total sum due to the Plaintiff.
