PARTICULARS OF CLAIM

- 1 On September 2, 2022, the Defendant borrowed \$1950.00 from the Plaintiff and agreed to pay back the full amount plus 20% of the amount borrowed by September 30, 2022, of a total of \$2340.00
- 2 A contract was signed between the Plaintiff and the defendant fully explaining the terms and conditions including the late fees and legal action. to which the defendant stated that she fully understood. The Defendant has borrowed from us on several occasions

- 4 On September 30, 2022, the plaintiff called the defendant about the payment, and she replied that she paid online thru transfer, and she has the conformation,
- 5 On Monday October 3,2022 the plaintiff called the defendant concerning the transfer that she made, and the defendant replied that she did the transfer but the bank took back the transfer because she had a standing order but she will go and speak to the bank about returning her funds so she can pay the plaintiff.
- 6 On Tuesday October 4, 2022, the defendant came to the plaintiff office and asked for an extension for payment to October 31, 2022, the plaintiff stated rowing that she had enough of this foolishness and will pay off the loan end of October 2022. The plaintiff agreed and the defendant signed a new contract for the amount of \$\$2,868.00 to be paid on or before October 31 2022.
- 7 On Monday October 31 2022 the plaintiff called the defendant about the payment and the plaintiff informed that she was about to make the payment . At 1:00pm the said date the defendant whatsapp up the plaintiff stating that she had covid and she had no monies to pay. And she is asking for an extension until November 29, 2022. The defendant was reminded that she requested the same thing last month and again no payment.

- 9 As of Tuesday November 8, 2022, the Defendant has an outstanding balance of \$2,868.00 \$50.00 late fee for the first day late as per contract. and as per contract 50% to be added to the balance total \$1,434.00 and simple interest at 5% \$0.59 per day

- (1) The sum of \$4,352.00.
- (2) Fixed costs of \$150.00, \$25.00 filing fee and process server fee \$125.00 alternatively costs to be assessed.
- (3) Interest at \$0.59 per day
- (4) Total sum \$4,652.00
