

PARTICULARS OF CLAIM

1. Between November 2019 to January 2020 the defendant, without the knowledge and/or consent of the Plaintiff, used the Plaintiff's Cayman National Bank Debit card to purchase various items online and over the telephone from local and international merchants to the amount of Four Thousand Three Hundred and Sixty Three Cayman Islands Dollars (CI\$4,363.00).
2. In January 2020 when the Plaintiff discovered this theft, he approached the Defendant about it and she admitted taking and using the Debit Card number to make the purchases.
3. The Plaintiff then gave the Defendant an opportunity to repay him the stated sum over six months during which the Defendant has only paid CI\$700.00 and has stopped paying back the monies in July 2020, leaving a balance of CI\$3,663.00.

AND the Plaintiff claims:

- (1) The sum of \$3,663.00
- (2) Interest in the sum of \$
- (3) Interest to continue until this matter is settled.
- (4) Fixed costs of \$175.00 or, alternatively costs to be assessed.
