APPLICATION FOR GRANT OF LETTERS OF ADMINISTRATION

And I undertake that in the event of such grant being made to me:

- (a) within six months of such grant to me of Letters of Administration I will prepare a true inventory of the said estate and exhibit and file the same in the Probate Registry of the Grand Court of the Cayman Islands; and
- (b) within one year of such grant to me, I will administer the said estate according to the law and directions, if any, of the courts and file in the Probate Registry of the Grand Court of the Cayman Islands a general account accounting for the whole of the assets of the said estate.

BOND

And I declare myself (and my successors) to be jointly and severally bound unto the Financial Secretary of the Cayman Islands in the sum of CI\$ 1,477,640 (US\$ 1,802,000).

The condition of this obligation is that if the above named does, when lawfully called upon in that behalf, make or cause to be made a true and perfect inventory of the said estate and does exhibit the same in the Probate Registry whenever lawfully called upon so to do and do well and truly administers the said estate according to law and does make or cause to be made a just account and distribution account thereof wherever lawfully so required, then this obligation shall be void and of no effect, but shall otherwise remain in force and effect.
