SECTION 23(1)**



GORDON LONNY JACOBS of 150 Heath Street, West Suite 1001, Toronto, M4V 2Y4 and PIERS DAVID BARCLAY, duly authorised Officer of EMBLETON TRUST CORPORATION LIMITED of 20 Cursitor Street, London, EC4A 1LT, United Kingdom being the executors (together, the "Executors") named in the Will of David George Norman, deceased (the "Deceased"), Probate of which was granted to the Executors out of The High Court of Justice of England and Wales, the Principal Registry of the Family Division in the United Kingdom on 18 February 2022 (being the equivalent of a Grant of Probate under the laws of the Cayman Islands and hereinafter referred to as the "Grant of Probate"), the Executors not having renounced Probate, Gordon Lonny Jacobs being over the age of eighteen years and the said Grant of Probate, together with the Death Certificate, being annexed hereto, HEREBY APPLY for Resealing of the Grant of Probate of the estate of the said Deceased and enclose our Affidavit in that behalf and undertake that in the event of a Resealed Grant being made to us, we will:

1. within six months of the Resealed Grant prepare a true inventory of the said estate in the Cayman Islands and exhibit and file the same in the Probate Registry; and
2. within one year of such Resealed Grant, arrange to have the assets comprising the said estate in the Cayman Islands administered according to the directions, if any, of the Court and file in the Probate Registry a general accounting for the whole of the assets of the said Cayman Islands estate.

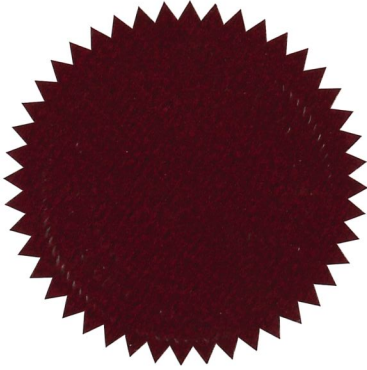
