PARTICULARS OF CLAIM

1. The Defendant is and was at all material times a Cayman Islands licensed company carrying on business pursuant to the laws of the Cayman Islands. The Defendant’s registered office is located at 7 Archie Street, North Sound Estates, Bodden Town, Grand Cayman.
2. On 21 December 2022, the Defendant issued a cheque to Cayman Islands Government for the payment of import duties, which was dishonoured by the bank and returned to the Government due to insufficient funds. The details of the dishonoured cheque are:

3. The total sum owed to the Cayman Islands Government is CI\$7,939.13.
4. Notwithstanding the demands for payment being made on the Defendant, the Defendant has failed to pay the debt in full.
5. To date the Defendant has failed or neglected to make full payment on this amount to the Plaintiff, despite repeated demands for payment.
6. As a result of the above, the Plaintiff is entitled to the relief claimed in this proceeding.

AND THE PLAINTIFF claims:

- a. CI\$7,939.13 being the total sum due to the Plaintiff.
- b. Fixed costs at CI\$150.00 or as to be assessed.
