THIS WRIT OF SUMMONS has been issued against you by the above-named Plaintiff in respect of the claim set out on the next page.

Within 14 days after the service of this Writ on you, counting the day of service, you must either satisfy the claim or return to the Court Office, P.O. Box 495G, George Town, Grand Cayman, the accompanying Acknowledgment of Service stating therein whether you intend to contest these proceedings.

If you fail to satisfy the claim or to return the Acknowledgment within the time stated, or if you return the Acknowledgment without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgment may be entered against you forthwith without further notice.

STATEMENT OF CLAIM

1. The Plaintiff's date of birth is the 9 January 1966 and her address is 124 Moonbeam Drive, Newlands, Grand Cayman. She is employed as an Insurance Claims manager.
2. The Defendant was and is at all material times the owner/occupier of a supermarket known as Cost-U-Less located at 51 Lime Tree Bay Avenue, Grand Cayman, to which they invite members of the public to enter for the purpose of purchasing goods.
3. On the 31 December 2022, the Plaintiff visited the store with her husband with the purpose of purchasing some goods and supplies.
4. At approximately 11.45am, as the Plaintiff was leaving the store carrying a tote bag over her shoulder and her cell phone in her right hand, her left leg slipped and she fell to the ground, sustaining personal injuries.
5. The Plaintiff fell to the floor hitting her left knee and also her right hand which she put out to brace herself. Her phone dropped onto the floor as she fell.
6. The Plaintiff lifted up her shoe and discovered a squashed grape. The accident happened in front of the customer service counter and there were a number of witnesses, and the Defendants employee immediately Margaret came over to attend to the Plaintiff.
7. The Plaintiff left the store with her husband in a state of shock, her husband packed the groceries into the car, and they proceeded to go home where she took pain medication.
8. The Plaintiff returned to the store with her husband on the 2 January 2023, after she had attended hospital and gave a full report to Margaret, the Employee who was in attendance on the day of the fall.
9. The accident and resulting injury were caused by the negligence of the defendant, its employees, servants or agent, or both.
10. Particulars of Negligence
 - (a) Failing to take any or any reasonable care to see that the plaintiff would be reasonably safe in using the premises as a customer;
 - (b) Exposed lawful visitors to danger or a trap and a foreseeable risk of injury;
 - (c) Failed to take any or any adequate care for the safety of the Plaintiff;
 - (d) Failed to take reasonable care to prevent injury or damages to the Plaintiff from unusual dangers on the premises;
 - (e) Failed to institute any or any adequate system of cleaning.

(f) Permitting the plaintiff to walk in the area when they knew or ought to have known that it was unsafe and dangerous for her to do so.

11. As a result of the Defendant's negligence, the Plaintiff has suffered personal injuries, loss and damage.

Particulars of Personal Injury

12. The Plaintiff's date of birth is the 9 January 1966 and at the date of the accident, she was 56 years old.

13. She suffered an injury to her left knee, right arm and lower back.

14. Prior to the accident, the Plaintiff had undergone a total knee replacement to her left knee in 2016.

15. The Plaintiff attended Doctors Hospital on the 2 January 2023 with a painful wrist, knee and contusion and bruising to her lower back and sacrum. She was provided with pain medication and underwent imaging.

16. She was diagnosed as having suffered full thickness tear of her right scapho lunate ligament and underwent surgery on the 20 January 2023.

17. She attended weekly at Doctors hospital for dressing changes.

18. She has undergone physiotherapy for her lower back pain and on her wrist.

19. She has had significant difficulty sleeping due to the pain and restrictions on her home and working life.

20. The plaintiff still suffers ongoing discomfort, especially when she has been particularly active or sitting or standing for long periods of time.

Particulars of Loss and Damage

21. The Plaintiff's particulars of special damage will be forwarded in due course by way of a Schedule of Loss including but not limited to claims for cost of past and future medical treatment, loss of earnings and care.

Statement as to Interest

22. The Plaintiff will claim interest pursuant to section 34 of the Judicature Law (2021 Revision) at half the rate as prescribed under the Judgment Debts (Rates of Interest) Rules (as amended) from the 31 December 2022 to Trial.

AND THE PLAINTIFF claims:

- (1) Damages;
- (2) Interest for such period and at such rate as the court thinks fit pursuant to section 34 of the Judicature Act (2021 Revision);
- (3) Such further or other relief that the Court deems fit;
- (4) Costs.

**DIRECTIONS FOR ACKNOWLEDGMENT OF SERVICE
OF WRIT OF SUMMONS**

1. The accompanying form of Acknowledgment of Service should be completed by an Attorney acting on behalf of the Defendant or by the Defendant if acting in person.

After completion, it must be delivered or sent by post to the Law Courts, P.O. Box 495, George Town, Grand Cayman.

2. A Defendant who states in his Acknowledgment of Service that he intends to contest the proceedings must also serve a defence on the Attorney for the Plaintiff (or on the Plaintiff if acting in person).

If a Statement of Claim is indorsed on the Writ (i.e. the words "Statement of Claim" appear on the top of page 2), the Defence must be served within 14 days after the time for acknowledging service of the Writ, unless in the meantime a summons for judgment is served on the Defendant.

If the Statement of Claim is not indorsed on the Writ, the Defence need not be served until 14 days after a Statement of Claim has been served on the Defendant.

If the Defendant fails to serve his defence within the appropriate time, the Plaintiff may enter judgment against him without further notice.

3. A Stay of Execution against the Defendant's goods may be applied for where the Defendant is unable to pay the money for which any judgment is entered. If a Defendant to an action for a debt or liquidated demand (i.e. a fixed sum) who does not intend to contest the proceedings states, in answer to Question 3 in the Acknowledgment of Service, that he intends to apply for a stay, execution will be stayed for 14 days after his Acknowledgment, but he must, within that time, issue a Summons for a stay of execution, supported by an affidavit of his means. The affidavit should state any offer which the Defendant desires to make for payment of the money by instalments or otherwise.

Notes for Guidance

1. Each Defendant (if there are more than one) is required to complete an Acknowledgment of Service and return it to the Courts Office.
2. For the purpose of calculating the period of 14 days for acknowledging service, a writ served on the Defendant personally is treated as having been served on the day it was delivered to him.
3. Where the Defendant is sued in a name different from his own, the form must be completed by him with the addition in paragraph 1 of the words "sued as (the name stated on the Writ of Summons)".
4. Where the Defendant is a FIRM and an attorney is not instructed, the form must be completed by a PARTNER by name, with the addition in paragraph 1 of the description "Partner in the firm of (.....)" after his name.
5. Where the Defendant is sued as an individual TRADING IN A NAME OTHER THAN HIS OWN, the form must be completed by him with the addition in paragraph 1 of the description "trading as (.....)" after his name.
6. Where the Defendant is a LIMITED COMPANY the form must be completed by an Attorney or by someone authorised to act on behalf of the Company, but the Company can take no further step in the proceedings without an Attorney acting on its behalf.
7. Where the Defendant is a MINOR or a MENTAL PATIENT, the form must be completed by an Attorney acting for a guardian ad litem.
8. A Defendant acting in person may obtain help in completing the form at the Courts Office.
