If you intend to defend the action, in whole or in part, you must set out **full particulars of your defence** in the space provided on the Acknowledgement of Service form.

**If you fail** to satisfy the claim or fail to return the Acknowledgement of Service form containing full particulars of your defence, the Plaintiff may apply for a **default judgment** without any further notice to you.


**PARTICULARS OF CLAIM**

THE PLAINTIFF claims that:

1. The Defendant was the tenant of the leased premises as set out in the Schedule attached hereto and the Plaintiff was the Landlord and was collecting the rent by its agent Jay Kidd.
2. The monthly rent was due and payable as set out in the Schedule attached.
3. The Defendant breached the said lease agreement by not paying the rent from February 2023 and the arrears are set out in the Schedule hereto.
4. The Notice to Quit dated 25<sup>th</sup> May 2023 was served on 29<sup>th</sup> May 2023 to give notice to terminate the tenancy as set out in the Schedule hereto.
5. Despite the tenancy having been ended as aforesaid Defendant has failed to pay the arrears of rent and failed to give up possession but has remained in occupation as a trespasser and owes damages for use and occupation until possession be given up.

AND THE PLAINTIFF claims:

1. Possession of the premises.
2. The arrears sum of \$2,600.00.
3. Court issue fee, \$25.00; fixed costs of \$150 and the Bailiff fee of \$30 = total \$205.00
4. Damages for use and occupation or “mesne profits” of \$534.25 to the date hereof and continuing as per the Schedule attached hereto
