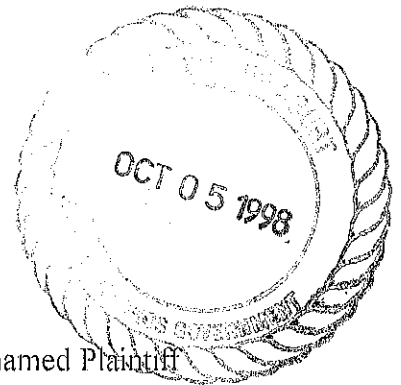
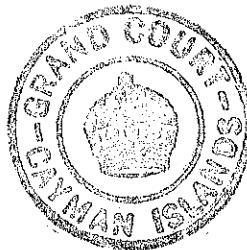

If you fail to satisfy the claim or to return the Acknowledgement within the time stated, or if you return the Acknowledgement without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgement may be entered against you forthwith without further notice.

NOTE - This Writ may not be served later than 4 calendar months (or, if leave is required to effect service out of the jurisdiction, 6 months) beginning with the date of issue unless renewed by order of the Court.

1. The Plaintiff is a cabinet maker.
2. The defendants are husband and wife.
3. Between the 14th August, 1996 and the 19th April, 1997 the plaintiff build cabinets for the defendants resulting in a debt of \$5,470.00 which despite several demands, the defendants have failed to pay.

Wherefore the plaintiff claims:-

1. The amount due \$5,470.00
2. Interest at rate of 7 7/8% per annum from
14th April 1997 to present = $(\$5,470 \times .07875 \times 539/365)$ \$ 636.11
2. Further interest at Statutory Rate
3. Costs to be taxed or agreed.
