If you intend to defend the action, in whole or in part, you must set out **full particulars of your defence** in the space provided in the acknowledgement of Service form.

If you fail to satisfy the claim or fail to return the acknowledgeable of Service form containing full particulars of your defence, the Plaintiff may apply for a **default judgement** without any further notice to you.

PARTICULARS OF CLAIM

1. The Plaintiff is and was at all material times a company duly incorporated in the Cayman Islands in the business of providing short term unsecured loans.
2. The Defendant at the material times was a resident of the Cayman Islands.
3. By a promissory note dated 13 August 2021 and executed by the Defendant (hereinafter referred to as the “**Agreement**”), the Plaintiff acknowledged a debt in the amount of CI\$ 3,433.34 to the Defendant and agreed to pay the Plaintiff the sum of CI\$ 3,433.34 on or before 1 December 2022.
4. The Defendant failed to pay the sum outstanding under the Agreement on 1 December 2022 despite demands for payment by the Plaintiff.
5. The Defendant made payments as follows:
 - a. CI\$ 250.00 on 1 October 2021; and
 - b. CI\$ 150.00 on 3 March 2022;
 - c. CI\$ 500.00 on 1 July 2022;
 - d. CI\$ 700.00 on 23 August 2022
 - e. CI\$ 150.00 on 19 October 2022;leaving an outstanding principal amount of CI\$ 1,683.34 which remains payable.
6. The Defendant agreed to pay all contractual costs on a full indemnity basis as in the Agreement. Contractual costs, as at 9 August 2023, are CI\$ 687.50 and continuing.
7. A letter before action dated 5 April 2023 has been served on the Defendant. The Defendant was given 21 days of service of the letter before action to pay the amount due under the Agreement. The amount owed under the Agreement remains outstanding and there has been no response as of the date of this claim.
8. The Plaintiff is entitled to payment of the amount which the Defendant promised to pay.

AND the Plaintiff claims:

1. The sum of CI\$ 1,683.34.
2. Contractual costs in the amount of CI\$ 687.50 as at 9 August 2023 and continuing;
3. Filing fees in the amount of CI\$ 25.00.
4. Process server fees.
5. Pre and post judgment statutory interest in accordance with Judicature Act (2021 Revision) on all other sums at the rate prescribed by the rules.
