PARTICULARS OF CLAIM

1. The Plaintiff is and was at all material times a company duly incorporated in the Cayman Islands in the business of providing short term unsecured loans.
2. The Defendant at the material times was a resident of the Cayman Islands.
3. By a promissory note dated 11 October 2021 and executed by the Defendant (hereinafter referred to as the “**Agreement**”), the Plaintiff acknowledged a debt in the amount of CI\$ 4,345.00 to the Defendant and agreed to pay the Plaintiff the sum of CI\$ 4,345.00 on or before 31 May 2022.
4. The Defendant failed to pay the sum outstanding under the Agreement on 31 May 2022 despite demands for payment by the Plaintiff.
5. The Defendant made payments as follows:
 - a. CI\$ 250.00 on 29 November 2021;
 - b. CI\$ 200.00 on 20 January 2022;
 - c. CI\$ 1,500.00 on 29 May 2023;leaving an outstanding amount of CI\$ 2,395.00 which remains payable.
6. The Defendant agreed to pay all contractual costs on a full indemnity basis as set-out in the Agreement. The legal costs as at 7 August 2023 are CI\$ 1,187.50.
7. A letter before action dated 12 April 2023 has been served on the Defendant. The Defendant was given 21 days of service of the letter before action to pay the amount due under the Agreement. The amount owed under the Agreement remains outstanding.
8. The Plaintiff is entitled to payment of the amount which the Defendant promised to pay.

AND the Plaintiff claims:

1. The sum of CI\$ 2,395.00.
2. Contractual costs in the amount of CI\$ 1,187.50 as at 7 August 2023 and continuing;
3. Filing fees in the amount of CI\$ 25.00.
4. Process server fees of CI\$ 70.00.
5. Pre and post judgment statutory interest in accordance with Judicature Act (2021 Revision) on all other sums at the rate prescribed by the rules.
