ORDER

UPON reading the letter of Harneys on behalf of the Joint Official Liquidators (*JOLs*) of TCA Global Credit Fund, LTD (In Official Liquidation) dated 16 August 2023 (the *Application*)

AND UPON reading the Second Affidavit of Tammy Fu dated 28 July 2023 and its Exhibit

AND UPON reading the email dated 16 August 2022 from Harneys on behalf of the JOLs

AND UPON the Court considering the Application to be suitable to be disposed of administratively without the need for an oral hearing

IT IS ORDERED that:

1. The remuneration agreement for the period 1 January 2023 to 31 December 2023 proposed by the JOLs is approved.
2. The JOLs' fees for the period 1 April 2022 to 30 September 2022 in the sum of US\$217,432.00 are approved.
3. The JOLs' fees for the period 1 October 2022 to 31 March 2023 in the sum of US\$75,762.50 are approved.

4. The Order of this Court dated 13 October 2022 is amended so that paragraph 2 of the Order reads:

"The fees and disbursements of the JOLs for the period 1 April 2021 to 31 March 2022 are approved by the Court in the sums of US\$265,057.20 for professional fees and US\$731.60 for expenses respectively."

5. The JOLs' costs of the Application be paid as an expense of the liquidation.
