PARTICULARS OF CLAIMS

Defendant was a tenant at #56 Gresscott Lane for the past 4 + years .
During her tenancy, Sheena Murphy exhibited inconsistent rent payment behavior.
Sheena moved out of the property without providing proper notice.

Complaint:

The Defendant failed to consistently pay rent in a timely manner throughout her tenancy.
The Defendant moved out providing the required notice, leading to financial and logistical challenges for the landlord.

Payment plan agreement:

On 8th April 2023, a payment plan was established between the Defendant and the Plaintiff to address her outstanding rent arrears.

The payment plan stipulated that the Defendant would pay CI\$500.00 per month over the course of 1 year as the Defendant will soon be on roll over.

The Defendant to these terms willing and verbally agreed with Mr. Wilks.

Default on payment plan.

Despite agreeing to the payment plan, The Defendant has defaulted on the agreement payment.

The Defendant has failed to make any payments as outlined in the payment plan agreement.


The default has caused financial strain on the Plaintiff, who relied on the agreed payment to cover expenses related to the property and funds to live off during retirement.

The action of the Defendant have caused fin


