PARTICULARS OF CLAIM

THE PLAINTIFF claims that:

1. This is a breach of contract claim.
2. Between 20th March 2015 and 14 September 2015, Defendant 1 borrowed the sum of \$6,000.00 for the care and benefit of Defendant 2, to be repaid with interest of 20% repayable on demand (to be repaid on receipt of a personal injury award on behalf of Defendant 2).
3. Repayment of this loan was demanded in 2019 but to date no payment has been received.
4. The Defendants should have to reimburse the Plaintiff for any costs incurred in bringing this action.

AND THE PLAINTIFF claims:

1. The sum of \$6,000.00.
2. Contractual interest in the sum of \$ 9,600.00 calculated at the agreed rate of 20% from 15th September 2015.
3. Interest to continue at the rate of \$3.29 per day until matter is settled.
4. Court issue fee, \$25.00; fixed costs of \$150.00 and the Bailiff fee of \$30.00 = total \$205.00
