Made this day of 15th July, 2023

I hereby revoke all former wills, codicils or other testamentary provisions at any time made by me and declare this to be my last will and testament.

1. MUTUAL WILL

This will gives directions to our family as to the disposal of our property after our deaths, whether our deaths occur separately or at the same time. We want all our children and their descendants to know how much we love and appreciate each of them. We have enjoyed the blessings of a loving family which helped us to survive the tragic loss of our eldest son at an early age. We treasure each of our seven remaining children, namely Monica Eileen Samuels, Margaret Ann Rivers, Lynford Rosevelt Evans, Yvonne Bodden, Jane Elizabeth Virtue, Robert Eric Cameron, Jewel Evans Lindsey, and we thank God for all the many ways in which they have enriched our lives. We also treasure our grand-children and great-grandchildren and pray God's richest blessings on all of our descendants, those living and those to come.

2. EXECUTORS

- 2.1 I appoint my son, Lynford Rosevelt Evans, of West Bay, Grand Cayman and my daughter Jewel Evans Lindsey of P.O. Box 2311GT, Beach Bay Road, Bodden Town, Grand Cayman to be my joint executors
- 2.2 If either Lynford Rosevelt Evans or Jewel Evans Lindsey is unable or unwilling to act or dies before proving my will, then I appoint Yvonne Bodden as executor in their place.
- 2.3 I declare that not more than two Executors shall execute my Will.

3. BURIAL ARRANGEMENTS

I have provided directions regarding my funeral and burial in a separate document. However, I confirm that my funeral is to be held in accordance with the directions given. I request that my body be buried at West Bay Cemetery in a vault located next to the vault in which my wife was buried after her death. It would be appreciated if a suitable headstone could be placed on the vaults in our memory.

4. PAYMENT OF DEBTS

All gifts are subject to the payment of my just debts, funeral and testamentary expenses and all fees payable.

5. FINANCIAL PROPERTY

I give and bequeath the funds remaining in any bank accounts held in my name to my to the other signatories of the bank accounts to distribute at their joint discretion after

payment of all debts and fees shall be divided into seven (7) equal shares to be distributed to each of our children or to their heirs and assigns.

6. REAL ESTATE

I give and bequeath my interest in the property registered as BLOCK NO 1D PARCEL NO 97 and located at 61 Poinciana Lane, West Bay, Grand Cayman to bequeathed to our sons, Lynford Rosevelt Evans and Robert Cameron, 60% and 40% respectively, their heirs and assigns; We request that the property – house and yard- be maintained in the manner in which we have kept it over the years. We pray that it will be a source of joy and comfort for all of our children and their descendants and that any child who has need will be allowed the use of the premises as agreed by the owners.

7. RESIDUE AND REMAINDER

I give and bequeath the residue and remainder of my estate both real and personal to wherever to be distributed in seven (7) equal shares to our seven (7) children or their heirs and assigns.




