2. As at 2 November 2023 the Defendant is indebted to the Plaintiff in respect of a MasterCard Standard #5425-6871-6471-0006 in the principal sum of US\$6,445.47 plus the interest which will continue to accrue at a rate of 20% per annum
3. The Plaintiff has made written demand for repayment by letter from its attorneys but the Defendant has failed to repay the said sum.

AND THE PLAINTIFF CLAIMS AGAINST THE DEFENDANT:

1. Payment of the total sum of US\$6,445.47;
2. Contractual interest on the above principal sum at the rate of 20% per annum and continuing until payment at the same rate pursuant to the Plaintiff's standard banking terms and conditions.
