PARTICULARS OF CLAIM

(Here set out in numbered paragraphs, the grounds upon which the Plaintiff claims that the Defendant is indebted to him or is liable to pay damages to him).

1. In March 2022, Wayne Bodden had agreed to procure and rebuild a custom Jeep. I had provided a total of CI\$10,000 to him in multiple deposits between the period of March 2022 to June 2022 for this jeep. He failed to deliver it after a 13 month period. It's important to note that Wayne had never showed me physical proof of the jeep or any progress made on it.

2. After the passing of 13 months, we agreed to have full repayment by April 7, 2023. Despite multiple requests and reminders for payment, Mr. Bodden provided the first repayment of CI\$1,000 on July 5, 2023 and a second of CI\$2,000 on Oct 11, 2023. Since then, he has avoided any sort of settlement of the matter, continuing to provide payment timelines that do not get met.

AND the Plaintiff claims:

1 The sum of CI\$,7000.

2 Interest in the sum of \$ 511.10, calculated at the prescribed rate from June 1, 2022 to date.

3 Fixed costs of \$ 175, alternatively costs to be assessed.
