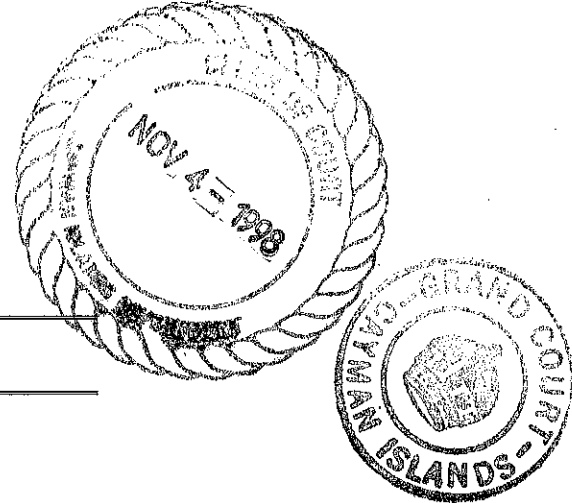

WINDING UP PETITION

TO THE GRAND COURT OF THE CAYMAN ISLANDS


The Petition of RODERICK ALLEN McLEAN of Global House, North Church Street, George Town, Grand Cayman, Cayman Islands sole director of Harris McLean Financial Limited ("the Company") shows that :-

1. The Company was incorporated on the 14th day of March 1994 under the Companies Law.
2. The registered office of the company is at Global House, North Church Street, George Town, Grand Cayman, Cayman Islands.
3. The principal objects for which the company was established are the provision of investment and other financial services as well as the other objects stated in the Memorandum of Association of the Company.
4. The Company is unable to pay its debts as they fall due and is accordingly insolvent.
5. In the circumstances it is just an equitable that the Company should be wound up.

AND THE PETITIONER THEREFORE PRAYS AS FOLLOWS:-

1. That Harris McLean Financial Group Limited be placed into liquidation and that Jeffrey M. Parker, F.C.A. of Moore Stephens, Chartered Accountants of Cayside, Shedden Road, George Town, Grand Cayman be appointed Official Liquidator of the Company.
2. That the Official Liquidator be at liberty to exercise any of the powers contained within section 109 of the Companies Law (1998 Revision) without the further sanction or intervention of this Honourable Court.
3. That the Official Liquidator provide this Honourable Court on a regular basis with reports on the progress of the Liquidation of the Company.
4. That the Official Liquidator be at liberty to employ such agents including attorneys at law in the Cayman Islands and elsewhere to assist him with his duties as Official Liquidator of the Company at such hourly rates as agreed from time to time by the Official Liquidator and such agents.
5. That the Official Liquidator be at liberty to charge for his services and also the services of employees of Moore Stephens, George Town, Grand Cayman at the following rates:-
 - (a) Partner CI\$160.00
 - (b) Manager CI\$100.00
 - (c) Account CI\$ 75.00
6. Such further and other relief as this Honourable Court deems appropriate.
7. That the costs of the Petitioner and the Petition be paid out of the assets of the Company.
