PARTICULARS OF CLAIM

1. The Plaintiff entered into an agreement with the Defendant to lend the sum of C\$10,400.00 in 2022 to which the Defendant signed the agreement to repay the sum in full by 1 April 2023.
2. The Defendant paid the sum of CI\$4,000 on 11 June 2022 leaving a balance of CI\$6,400. The Defendant then borrowed an additional CI\$6,350 bringing the total borrowed to CI\$12,750.
3. The defendant made a series of payments between 13 September 2022 to April 2023 totaling the amount of CI\$9400 leaving a balance of CI\$3,350. The Defendant was provided with receipts of the payments and the outstanding balance.
4. The Plaintiff have made numerous attempts for the balance of money outstanding to be paid by the Defendant. The plaintiff has sent messages to the Defendant regarding when payment would be received. The Defendant has made no effort to pay the outstanding balance since September 2023.
5. As at the date of filing this Plaint, no payment has been received from the defendant in relation to the balance which remain due and outstanding.

AND THE PLAINTIFF CLAIMS:

- 1 The sum of CI\$3,350 being the balance due and outstanding.
- 2 Interest at the rate to be assessed.
- 3 Costs of \$150.00, plus filing and bailiff fees of CI\$25.
